Terms and Conditions for Visa Reactivation Campaign

- Introduction: This document outlines the terms and conditions ("Terms") of the Visa Worldwide Pte. Ltd.'s ("Visa") campaign (the "Campaign") to re-activate Visa Consumer Credit Cards ("Card"). The Campaign is offered by Visa to holders ("Cardholder", "you", "your") of a valid and current Card ("Eligible Card") issued by a licensed issuer in India as listed in Appendix 1 hereto ("Issuer"). For avoidance of doubt, no Visa debit, prepaid, commercial, business or forex card shall fall within the definition of Eligible Cards or be eligible for any benefits under the Campaign. The Campaign is valid until stocks last.
- 2. Eligible Transaction: Any purchase transaction undertaken through an Eligible Card at any of the offline or online merchant establishments ("Merchant") (which may also include an "on-us transaction" staged on VisaNet by the Issuer of the Eligible Card), shall be an Eligible Transaction ("Eligible Transaction"). For the purpose of these Terms, 'on us transaction' shall mean a purchase transaction undertaken through an Eligible Card at any of the Merchants establishments and where the Card Issuer is also a Merchant acquirer.
- 3. Eligibility: To participate in the Campaign, you must:
 - be a Cardholder with an Eligible Card issued by the Issuer; and
 - be classified as an "Inactive Cardholder" (i.e. a Cardholder of an Eligible Card which has at least one Eligible Transaction between April 01, 2023 to January 31, 2024; but has no Eligible Transaction between February 01, 2024 to July 31, 2024)
- 4. Product return: Any product return, refund, or cancellation of the order for any reason will disqualify the Eligible Transaction from the Campaign.  - The Cardholder notes that Voucher can be earned only once during the Campaign Period on an Eligible Card.
 - Vouchers are non-transferable, non-exchangeable, and non-refundable. No cash alternatives or substitutes to the Vouchers will be provided.

 - Eligible Cardholders can claim their Vouchers by clicking on the Website, where they will have the option to "Claim" the Voucher by entering the card number and other details to claim such applicable Voucher.
 - The Voucher can only be claimed after 15 days from the Eligible Transaction Date, however, no later than 90 days from the aforesaid date. The Voucher details (i.e. the 13 digit numeric

code) will be available to the Cardholder on the Website upon claiming of such Voucher. Additionally, Visa may deliver the said details to the Cardholder via SMS.

- Once claimed and having generated the aforesaid 13 digit numeric code, Vouchers must be redeemed on Amazon India website or mobile application ("**Platform**") within 90 days thereof, else the Voucher will expire. Expired Vouchers cannot be replaced.
- Visa, Issuers and Merchants will not be responsible for any delay, loss, or damage in the delivery of the Vouchers..
- 8. General terms and conditions: By participating in the Campaign, you agree to/that:
 - o abide by these Terms and the decision of Visa with respect to the Campaign.
 - release and indemnify Visa, Issuers and Merchants from any liability, claim, loss, damage, cost, or expense arising from or in connection with the Campaign or the Vouchers.
 - understand that participation in the Campaign is voluntary and not binding in any manner.
 - accept that Visa reserves the right to modify, suspend, cancel, or terminate the Campaign and these Terms or any part of it without prior notice or reason.
 - accept that Visa has the sole and final discretion to determine the winners and the Vouchers, and that their decisions are final and binding.
 - o all taxes, fees, and surcharges on Vouchers are the sole responsibility of the Cardholder.
 - Visa reserves the right to disqualify any participant who tampers with the entry process or submits an entry not in accordance with these Terms or in any manners subvert or tries to subvert the objective of this Campaign.
 - Visa is not responsible for any technical failures that may prevent an individual from participating in the Campaign.
 - once awarded, the Voucher shall not be resold or commercially traded in any manner, directly or indirectly.
 - comply with the terms and conditions applicable to the issue and use of the Vouchers as decided by the Amazon and as available to the Cardholder on their Platform or terms and conditions of such other applicable voucher provider.
 - Visa may, in its sole discretion, provide an alternate voucher or such other benefit of equal amount.
 - nothing herein amounts to a commitment by Visa, Issuers or Merchants to conduct further similar or other Campaigns.
 - this Campaign is void where prohibited by law.
